COMMITTEE REPORTS

FINANCE AND FACILITIES COMMITTEE

Chairperson: Michael Pizur

Mr. Pizur gave an update on the recent Finance and Facilities Committee meeting.

2018-2019 AUDIT REVIEW WITH EDWARD MCCORMICK FROM MUELLER CPA

Ed McCormick presented the 2019 audit. He reported that the district is in good position, complies with acceptable accounting and reporting principals and has procedures in place to maintain accurate financial records.

DISCUSSION OF VARIANCES FROM BUDGET TO ACTUAL

Mr. Veihman presented the FY19 budget to actual report. He explained to the committee how actual property tax collections underperformed revenue estimates due to the tax collections, the timing of collection payments to the district and a significantly higher number of property tax refunds. Mr. Veihman also discussed at length unanticipated special education expenses that came in over budget for the fiscal year. As a result of the lower property tax collections and unanticipated special education expenses, the school district ran a deficit of approximately \$500,000. Dr. Scarsella noted that it will be increasingly difficult for the school district to balance future budgets due to the change in the state's school funding formula and historically low inflation.

REVIEW OF LONG TERM FINANCIAL PLANNING

committee discussed the merits of taxable vs. non-taxable working cash fund bonds.

SUPERINTENDENT'S UPDATE

SCHOOL REPORT CARD

On October 30, the Illinois State Board of Education released the 2019 School Report Cards. Highlights from this year's report card include strong academic gains in student growth and proficiency. Palos South and Palos East received a Tier 1 Exemplary School Summative designation for 2019 which places their performance in the top 10% of schools statewide. Palos West received a Tier 2 Commendable School Summative Designation which places West in the top 25% of schools statewide. All three Palos 118 schools are high performing and he congratulated students and staff on these outstanding results. HEALTH LIFE SAFETY COMPLIANCE REPORT

Thank you to Justin Veihman, Kathy Pagoria, Pete Messina, and the entire Operations Staff for their dedication to maintaining safe learning environments for our Palos 118 students. For the second year in a row, our school district had no safety violations identified during our recent annual life safety inspection.

5 YEAR STATE COMPLIANCE VISIT

Illinois Administrative Code requires that each school in Illinois has a compliance visit to ascertain if school districts are complying with state operational requirements and state and federal regulations. Palos 118 is the first school district in the South Cook region to achieve a perfect score on the district evaluation, staff licensure, and health/life safety inspection during its State compliance visit.

PALOS SOUTH OPEN GYMS

The Palos South gym will be open on Fridays from January 10 - March 20 from 6 – 8 p.m. At least one Palos Rec staff member will be present for supervision. This will be open to all Palos 118 students and younger siblings for \$2/child. All children must have a responsible adult to sign them in and remain present while the child is playing. A single adult can sign in multiple children.. Open gym participants will have access to the gyms, the fitness center, and hallway bathrooms. The rest of the school will be locked off from open gym participants. No food or drink will be allowed. Thank you to Dr. Cantorna, Justin Veihman, and the Palos Park Recreation Department for working together to make this program available.
