Palos 118 is excited to announce the use of the Rhithm app as a part of our response to COVID-19 and our commitment to supporting whole child development. Whether your child is learning in-person or remotely, Rhithm will help us better understand each student's learning readiness and respond to social and emotional needs during this time. The Rhithm app is a check-in tool that provides responsive support for students in just 3-5 minutes. Students respond to five questions centered around Mental, Energy, Emotional, Physical, and Social state and then can engage in brief mindfulness and well-being related activities that are tailored to student needs, build social-emotional skills, and help students get ready to learn. The close partnership between families and the school district is why our safety plan works and reason our schools remain open for in-person instruction. Even with falling positivity rates and vaccines on the horizon, nothing has changed with our safety plan. The importance of families notifying the school immediately if their child is symptomatic and/or receives a positive COVID-19 test is as important now as it was on our first day. Families refusing to follow our safety plan will have their children withdrawn from in-person learning and enrolled in remote learning for the safety and protection of their classmates and our school staff. We have had an outstanding track record of safety throughout the first semester. Let's continue to work together to keep students and staff safe during the second half of the school year.
